

Club Provisions

[Name]

Article 1: The gym is collectively referred to as the "Kurashi-no-Mori Climbing gym" (hereinafter referred to as the "gym").

[Objective]

Article 2: The purpose of this gym is to improve climbing technique, maintain and improve physical and mental health, and promote friendship among the members by using the gym facilities in accordance with the rules of this gym. The gym shall also serve as a place that contributes to the spread of free climbing.

[Management and operation]

Article 3: The gym is owned by Hattori Kogyo K.K in Kurashi-no-Mori, 30 Wakamiya, Hane-cho, Okazaki City, Aichi, and the office for the management and operation of the gym is also located at Hattori Kogyo K.K.

Article 4:

1. This gym is available to members only.
2. The person who joins and uses this gym must agree to these rules, observe the "Requests and Precautions When Using the gym", and submit a written agreement that complies with these rules to this gym and have it accepted by this gym.
3. Members must always present their membership cards when using the gym facilities.

Article 5:

1. Must be at least 18 years of age and follow the rules and regulations of this gym.
2. A person who is deemed by the staff to be fit to use the free climbing facilities.

[Membership Qualification]

Article 6: Membership shall be deemed to have been acquired upon completion of the contract set forth in Article 4, Paragraph 2.

[Handling of persons under 18 years of age]

Article 7: When a person under the age of 18 applies for membership or use of the facilities, in principle, the application must be jointly signed by the person himself/herself and a person who has parental authority over the person. In this case, the person with parental authority shall be jointly and severally liable with the applicant based on the rules of use of this gym, in the same way as if the applicant had become a member himself/herself.

[Transfer of membership]

Article 8: Membership of this gym is non-transferable.

[Strict observations of rules]

Article 9:

1. Members must strictly abide by these rules and regulations when using the gym's facilities.
2. Members must follow the instructions of the gym's staff when using the gym's facilities.
3. When using the facilities of the gym, members shall not engage in any conduct that is disruptive to the orderly operation of the facilities

[Exemption from Liability for Damages]

Article 10: The gym shall not be liable for any damages incurred by a Member due to reasons attributable to the Member while using the gym facilities.

[Member's Liability for Damages]

Article 11: If a Member causes damage to the gym or a third party due to reasons attributable to the Member while using the gym facilities, the Member shall assume full responsibility for the damage.

[Loss of membership]

Article 12: A member shall forfeit his/her membership and any rights as a member if any of the following occurs in such a case, the member must promptly return the membership card.

1. The Member requests to withdraw from the membership for reasons attributable to the Member and this gym accepts the request.
2. When expelled.
3. Death of the member himself/herself.
4. When all the gym facilities are closed due to unavoidable managerial reasons.

[Expulsion of members]

Article 13: The gym may expel a member from the gym if the member falls under any of the following. The member shall forfeit all membership privileges at the

time of expulsion. In such case, the member must promptly return the membership card.

1. When a member violates the rules and regulations of this gym.
2. When a member has damaged the honor of this gym, disrupted the order of this gym, or acted in a manner unbecoming of a member of this gym.
3. Failure to pay the facility usage fee and other fees.
4. Other cases in which the staff deems the member to be unsuitable as a member of this gym.

[Temporary Closure of Facilities and Temporary Leave of Absence]

Article 14: The gym may close all or part of the facilities or suspend operations in the following cases. In such a case, the gym shall give notice to that effect at least one week in advance in principle.

1. When it is judged that the disaster is caused by a weather disaster or other external causes and that the disaster will affect the member.
2. When it is unavoidable due to modification or repair of the facility.
3. When unavoidable due to other serious reasons.
4. Due to regular holidays (summer, New Year holidays, GW, climbing competition days), etc.

[Prohibition of Use]

Article 15: The use of the facilities by any person who falls under any of the following items shall be prohibited.

1. A person who has a contagious disease or any other disease that may be contagious or infectious to others.
2. Persons who are found to be incapable of using the facilities normally due to alcohol consumption.
3. Other persons who are prohibited from exercising by a physician.

[Change of Expenses, etc.]

Article 16: The gym may change the fees to be paid by the Members in accordance with the Constitution and Regulations, depending on changes in social and economic conditions. In this case, the gym must give at least one month's notice.

[Revision of the Regulations]

Article 17: The Constitution and By-Laws may be revised by the gym. The revised constitution and by-laws shall be effective for all members.

[Use of Walls]

Article 18: Members authorized by the regarding Mountain Walls and Lead Walls may conduct lead climbing and lead climbing villages. In addition, other hanging descent, multi-pitch, etc. may be performed by the authorized member on a case-by-case basis.

[Training Course]

Article 19: In the event of the training course, the member shall notify the staff in advance for permission.

[Prohibition of Sale of Goods]

Article 20: The following business activities are prohibited in the gym and on the premises without permission.

1. Sales of goods and similar activities
2. Handouts/leaflets
3. Solicitation
4. Any other act that interferes with the operation of the gym.

[Alteration or modification of the wall]

Article 21: No changes or replacements of holds, carabiners, bolts, etc. on the wall shall be made without permission.
